# **Property Taxes**

Outagamie County has implemented a new software for collecting taxes. It may take longer than usual to pay your taxes; your patience will be appreciated!

Taxes are due in full by January 31, 2018, or you may use the installment plan. If you pay your taxes using the installment plan, the due date for the 1<sup>st</sup> installment is January 31, 2018. Please be sure to pay the amount as stated on the 1<sup>st</sup> installment stub. You only need to send the stub along with your payment. There is no need to send the entire tax bill.

Full payment or the 1<sup>st</sup> installment should be sent to Sherri Fassbender, Treasurer, W7826 Mason Street, Hortonville, WI 54944. The second installment is due July 31, 2018, and must be sent to the Outagamie County Courthouse, 410 S. Walnut Street, Appleton, WI 54911.

Payments postmarked December 31 will be credited for 2017.

If you would like a receipt, please include a self-addressed, stamped envelope with your payment.

### News from the Chairman by Joe Schumacher, Chairman

The town has ended on a positive note financially. We were able to complete all of our road projects we anticipated on doing this year, such as smear patching a large amount of roads. This is just a band aid to carry us over until we are able to either reconstruct, or repave the roads in desperate needs.

Four roads in Stephensville were milled and paved that were so broken up it would be nearly impossible to snow plow. This work was performed by Northeast Asphalt.

We did various ditching projects this year throughout the town, along with replacing two big culverts that received county aid to cover the cost of the pipe and labor for installation.

Numerous roads were painted this year because of the fading of the paint that happens because of the time span from the last time they have been painted. We have received many compliments on how nice it is to see the roadway during adverse weather with the painting of the roads in our township.

The town completed all of the tree trimming we wanted to do, we know there is more to do, but we are planning on doing some more next year.

The town board has quarterly meetings with the fire department which we listen to any of their concerns they may have. This year we have updated the fire hall with new more energy efficient lighting. The concern was when people walked into the fire hall it was so dark, we installed motion sensor light so they wouldn't have to enter the building in the dark. We also changed the water fill pipe for the trucks so they can be filled from the ground instead of having to climb up on top of the trucks to perform these duties. The Fire Department has brought it to the board's attention that they may be looking at replacing a truck and water truck with one truck, but the cost is projected to be \$750,000. We advised them that we should let the residents towns people know about the cost and how we are going to fund such a large purchase. The Fire Department is doing a great job in keeping us safe...THANK YOU!

The town is going to petition the sewer district to provide sewer service to the parks pavilion. At this time it is being served with a holding tank. We have been experiencing some problems with water seeping into the tank and the pavilion being rented out every weekend from spring through fall we had to pump it weekly. The town was advised by our attorney that the sewer district could bill us for all of the cost to put the sewer line in. The town had a cost estimate from years ago which was \$540,000 dollars. We are going to have to do something sooner than later. The town is trying to find some funding that may be available for these improvements. We already checked into what the interest rate may be to borrow money from the Trust Fund. The rate is between 2.75% and 3.00%. The town has borrowed money numerous times from the Trust Fund which has a very favorable interest rate.

We are just putting out a friendly reminder that pushing snow across any road is prohibited. If this happens, the town will have to take legal action against them. This is just a reminder to protect the general public that uses our roads that there aren't any obstacles that may be hit.

The town also has a no bare road policy. We understand that at times the roadways could be slippery or snow covered, but we will try the best to make the roads safe for the general public.

To keep your holidays fun and safe, here are a few great ideas to follow:

- Make sure to change your smoke detector and carbon monoxide detector batteries and test them
  monthly. You should have a working smoke detector and carbon monoxide detector on each level of
  your home.
- Clean your chimneys, fireplaces and have your furnaces inspected once a year before using them.
- When using candles, make sure they are in a noncombustible container or holder and make sure they are blown out before leaving home or going to bed.
- When buying a real Christmas tree, be sure to pick a <u>FRESH</u> tree. You'll know it's fresh if the needles are firmly attached. Once you have your tree at home, keep plenty of water around the base. A dry tree is a source of many home fires every year. Some trees can take up to 3-4 gallons of water a day.
- ♦ Be bright about lights! Don't use lights with worn insulation, broken plugs and loose sockets. They can cause fires, shocks and even electrocutions!
- When using space heaters, give them space. Keep curtains, bedspreads, and furniture away from them and make sure children know they could get burnt if they touch them.
- Be careful when hanging stockings and other items around the fireplace or chimneys.
- When doing holiday cooking, make sure to not leave things in or on the stove unattended. Many fires around the holidays start in the kitchen and spread very quickly. Keep turkey fryers outside and away from combustible materials. Make sure to measure out the proper amount of oil to be used and always fry thawed foods. Frozen foods will cause the oil to erupt into a fire ball.
- Make sure to have emergency numbers and addresses posted by your phones. With family and friends coming over for the holidays, not everyone knows what numbers to call in case of an emergency. These numbers should also include plumbers, furnace repair companies, utility companies (gas and electric), local hospitals, and poison control. For emergencies for fire, police and medical call 911.

The Ellington Fire Department and Ellington First Responder members would like to thank ALL the residents for their continued support over the past years. As the town grows and the needs of the community are changing, the fire department has come up with a 20 year plan to start replacing equipment and vehicles. In the next year or two, we are looking to replace two older fire trucks and purchase one new one. The trucks that are looking to be replaced are a 1972 engine and a 1994 tender. These are the department's oldest vehicles in service and are starting to cost more and more money to keep them updated and maintained. The goal is to replace these with a pumper tender. At this time, the department is still getting prices and are just beginning to look at different options for this type of fire truck. The fire department will be bringing this topic up at the next Annual Town Meeting for more discussion.

As always, the main goals for the fire department and first responders are to protect the lives and property of this great community.
